



**OCONTO FALLS PUBLIC SCHOOLS  
RENTAL FEE SCHEDULE**

**CLASS I**

Free use of school facilities may be granted to the following organizations or groups, provided that membership is composed of not less than 75% local residents and is open for participation to any local citizen.

- A. Oconto Falls School District affiliated groups
  - 1. Parent groups, teachers' associations, scholarship associations, school committees, booster clubs, county or state school performances, etc.
  - 2. School-related youth organizations
- B. Boy Scouts, Girl Scouts, 4-H, Youth Service Clubs, etc.
- C. Senior Citizen Groups
- D. Government Meetings
- E. Other qualifying organizations as determined by the Superintendent or Assistant Superintendent.

**CLASS II**

Fees shall be charged for the use of school facilities by approved religious, charitable, philanthropic, and cultural groups, service clubs, fine arts associations, recreation departments, theater groups, and other non-profit organizations **located within the district** that are devoted to community interest and child welfare.

**CLASS III**

Fees shall be charged for the use of school facilities by approved religious, charitable, philanthropic, and cultural groups, service clubs, fine arts associations, recreation departments, theater groups, and other non-profit organizations **not located within the district** that are devoted to community interest and child welfare.

**CLASS IV**

These fees will be charged for use of school facilities by "for profit" organizations.

**P.A.C. LABOR CHARGES FOR CLASS II, III, IV RENTALS OF PERFORMING ARTS CENTER (TO BE FILLED OUT BY PAC MANAGER/DIRECTOR)**

- P.A.C. Manager/Director is required at all times (Included in base fee for standard services)
- Technical Crew - \$8 per hour / per person (Can be provided by lessee with advance approval)
  - 1. Light control technician
  - 2. Sound control technician
  - 3. P.A.C. Stage crew (1 person minimum)
- Custodian fee \$20 per hour (3 hour minimum) dedicated to Lessee
- Piano User Fee \$60.00
- The school district reserves the right to add additional laborers and breaks if the crew call is not within realistic limits.
